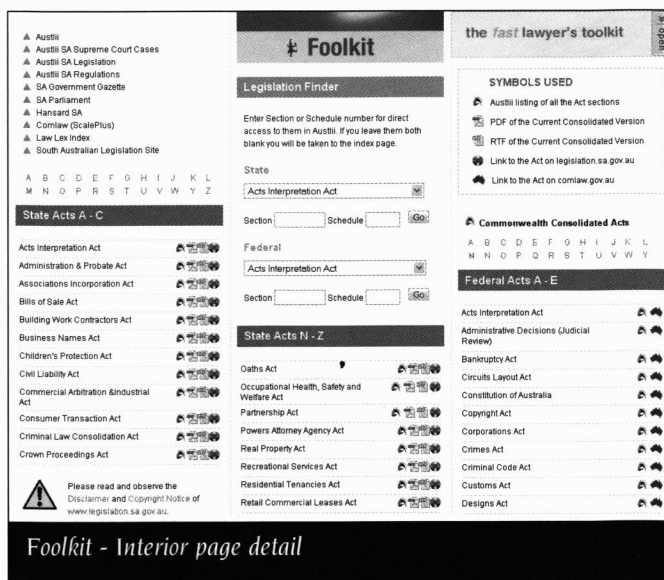


Practice Management: Launch of www.foolkit.com.au
